Discussion and business undertaken by the Board

- Presentation to new graduates the board chair met with second-year students of the Victoria
 University of Wellington Master of Music Therapy programme in the middle of 2021 to help them
 understand the requirements of applying for registration;
- A substantial number of new graduates applied in August for registration when they had completed their course of study. A few applications for overseas applications were approved as well.

- The Chair received positive feedback for the Registration Board presentation at the 2021 Symposium which aimed to support and clarify processes for registered music therapists.
- The first year of the 2022 renewal fees being due from 1-30 April was mostly successful although around 20 people still made payment prior to 31 March in the 2021/22 financial year.
- Newsletters were sent to RMThs in September and November 2021 and January 2022.
